IFU is looking for a student, who is motivated and passionate about working with commercial and sustainable investments that create impact in countries across Africa, Asia, Latin America and parts of Europe.

**Do you want to work for an international investment fund creating economic and social development in developing countries through impact investments? IFU makes direct investments (equity and loans), using its own funds and as fund manager of investment funds.**

IFU is Denmark’s Development Finance Institution. We strive to be a best-in-class impact investor by making commercial private sector investments that support the green transition, as well as building just and inclusive societies in developing countries and emerging markets. IFU has a strong focus on creating sustainable and responsible businesses, which generate measurable social, economic and climate impacts as well as solid financial returns.

### **THE JOB**

In this role you will assist IFU’s legal team with legal tasks, and you will gain broad insight into the daily tasks in a legal department. You will solve internal tasks within e.g. company law, compliance and updating of standard documents, as well as external tasks for IFU’s investment team.

Your primary tasks as a student in the legal team will be:

- Legal work, e.g. preparing draft agreements, reviewing and commenting on drafts by other parties
- Legal research
- Updating standard documents, internal directives and guidelines, tax overviews, international lawyers’ lists, etc.
- Administrative work regarding subsidiaries, e.g. drafting minutes of annual general meetings and board meetings and making registrations with the Danish Business Authority
- Compliance tasks, e.g. reading new legislation relevant to IFU, updating policies
- Legal ad hoc tasks

Your work schedule will be flexible, 15-20 hours weekly, taking exams into consideration.

### **THE TEAM**

You will be part of the legal team of nine people, including two students. The team solves many different tasks, and no two days are alike. The legal employees are all lawyers with international experience, and some have the right to appear before the courts in other countries. So, there is ample opportunity to gain experience with complicated transactions, international investments, international organisations, etc.

Joining IFU, you gain a job in a unique international investment fund, and you will be part of the team of students across IFU., who are assisting and helping on key areas in the organisation. As a student in IFU, you will get familiar with how we work and create impact through investments in developing countries and get exposure to the investment process and impact creation work, working with experienced colleagues and other students.

In IFU we attach great importance to good teamwork and collaboration, maintaining a positive atmosphere and having fun together. We help each other out, share our knowledge, and – while each of us hold high standards and integrity to our work – we don’t take ourselves too seriously and share a good laugh.
